### 1. Committee Meeting.

#### 1.1 Club Chairman

There is not much to report so soon after the AGM. The only thing which is of some concern is that despite requests from both myself and Rory, not one person has shown any interest in joining the Denmead 10k committee. This puts the future of the race after 2019 in doubt and we risk losing the valuable funding for the club and the benefits to members that it creates.

We will make further requests and monitor the situation closely.

#### 1.2 Vice Chairman

The vice chairman had nothing to report.

#### 1.3 Club Secretary

Matters Arising from 8<sup>th</sup> January meeting:

Ladies T Shirts: Minimum order requirements had now been met and ladies T shirts are available to order via the club web site.

First Aiders: As previously agreed we will wait until June for funding for training. Several people had shown an interest and one member had supplied some first aid kits which will be available at training sessions.

From AGM – Winter Training Venue: The secretary will find out from Steve Trevenna what the status is and follow up if required.

#### 1.4 Club Treasurer

The treasurer was unable to attend but reported that we had high income due to subs being paid. Main outgoings were EA fees (club and members), £550 to Pompey Joggers for Summer Cross Country, £943 for Awards Night and £139 for Ryde transport. The accounts are appended.

### 1.5 Membership Secretary

The membership secretary reported that most subs had now been paid and we currently have 149 paid up members. Some more were expected with the move to summer training.

### 1.6 Club Captains

Ladies: Kirsty Aked reported

At the time of reporting Salisbury results had not been updated. Up to Fleet the ladies A team are 2<sup>nd</sup> in Division 1 and the B team are 5<sup>th</sup>. We had good turnouts at Fleet and Salisbury with several ladies getting PBs and some incredible performances.

With only 4 races left we are struggling to get full teams, currently there are only 2 ladies down for Alton. Lordshill should see full teams as it is also our club championship but it would be a shame to lose our good position through lack of full teams.

Men: Gary Armstrong was welcomed as the new men's captain and reported:

Again, Salisbury results had not been added to the league positions. We had good performances from the men's teams at Fleet. The men's A team has gone down to 5<sup>th</sup> place in A division 1, the B team are 5<sup>th</sup> in B division 1 and the C team are 2<sup>nd</sup> in B division 2.

There are some really strong performances with people with good PBs struggling to get in the C team. We should have full men's teams for the last 4 races so should finish the year in a higher position.

### 1.7 X-Country Representative.

Paul Welch was unable to attend but as the season is now finished there was nothing to report.

### 1.8 Striders League.
