### 1. Committee Meeting.

### 1.1 Club Chairman

Clare Welch reported;

First of all welcome Jenny to the committee in her role as Members Rep. I think we can all agree she will be a valuable member of the team.

### 1.4 Club Treasurer

### Stuart Hoare reported;

The accounts of the club show a healthy balance for the year to date of reserves at around £4,000 For the period January 2024 to date the club has received the majority of the subscriptions from its members and have paid over the England Athletics their contributions, the remining balance received from its members has covered the running costs of the club as shown on the accounts summary.

For the Denmead 10K race, this is predicted to make a surplus as the current entries received for the race are close the maximum.

The committee will decide on how to use the surplus of funds once such values have been calculated.

At present the club is holding the entry fees paid on account to cover the anticipated costs for running the Denmead 10K, these will follow at the time of the event.

## 2024 / 25 season provisional race schedule

We had the AGM early August & heard from the clubs who organised races last season, the current provisional list of races are, unfortunately only one has a confirmed date at the moment:

- 1. Benyon's Enclosure Inglefield Estate (near Silchester) 3rd November 2024.
- 2. The Bourne Woods Late November 2024.
- 3. Lord Wandsworth College December 2024.
- 4. Chawton House January / February 2025.
- 5. Alice Holt Feb 2025. TBC (all clubs are requested to supply volunteers for this event)
- 6. Fareham (Venue TBC) 2nd or 9th March 2025.

### EA requirements

There was a long discussion about the requirement of non-affiliated runners having to pay £2 per race, this is to allow them to be covered by the EA insurance. However, this has become quite a large administrative task for the race organisers. The discussion was whether to allow non-affiliated runners / clubs to participate, and the outcome was yes for this season, but with the intention to restrict it for coming seasons.

### SCCL finance update

The League currently has funds of around £100, with the following projected income and expenditure:

Income:

Affiliation fees: £100 per club = £2,300

Expenditure:

First aid provision: £1,050 Portable toilet facilities: £1,320

England Athletics "Competition Provider" licence: £150 (required for all umbrella organisations under

which clubs organise races) Website hosting fees: £200

The race organisers confirmed that some venues would need additional portable toilet facilities:

Benyon's enclosure Chawton House The Bourne Woods

Based on the projections we would have a shortfall in the League bank account by the end of the season.

### Affiliation fees

Due to this potential increase in expenditure from the need to pay for portable toilet facilities, a discussion took place over whether we should increase the income generated from affiliation fees for the 2024 / 25 season. A number of club reps expressed their comfort with paying a higher affiliation fee.

A vote was held on the proposal to increase the fee to £125:

Vote: Should we increase affiliation fees to£125 per club.

Outcome: yes, we should increase.

I assume that the club is still happy to proceed with this increase. The committee agreed to go ahead.

#### **AOB**

- · It was discussed about expanding the league, but the vote decided that there will be no increase in numbers due to already high numbers of participants.
- · Can. participants can wear a club's "reserve" or "alternative" colours this is permitted.
- $\cdot$  What the minimum age for participants was under-18s may not take part in the races, but anyone from an older age category is permitted to take part
- · Whether there has been any discussion on participation by transgender athletes no clarity on this yet, but the league has reached out to England Athletics for their guidance.

### 1.8 Striders League.

Graham Clarke reported;

The final league race of the season took place at Lordshill on July 7th with an impressive 29 Striders taking part!

Participation in the League this year has been very enthusiastic with 88 Striders competing in at least one event, 23 members earning themselves bonus points in the HRRL races while 27 were awarded earned bonus points in the XC races.

Striders' League Status for 2024-25 Season

The inaugural event of the Striders' League competition for the new season starts with the Overton 5m on 8th September.

I have prepared the scoresheets and updated the rules for the new season on the website making the following minor changes from last year:

- 1. The events qualifying for acquisition of League points will be:
- · All 12 of the HRRL races (same as last year without the Hayling 10 m)
- · All 6 of the SCCL races, assuming that they will be the same six races as planned last year.

If anyone would like to see any additional (non-HRRL) races included as in previous years please let me know and I can easily modify the spreadsheets accordingly

2. The Age Grading Calculators are updated from time to time and in previous years I have been using 2006/10 version. This year, unless anyone has any objections, I propose that we use the more recent data from 2015.which has been modified from the earlier data due to the fact that world records are continuously being beaten! The consequence of this change is that individuals will receive slightly reduced age grades for their performance compared with previous years. However, this will apply to all member so will not affect their overall positions in the league at the end of the day! If anyone wishes to check that I have allocated the correct score to them after each race, the calculator is available on the following website:

## 2.0 Coaching

### Gary McCawley reported;

The winter schedule for 2024 & 2025 has been completed. The schedule contains the usual mix of intervals, hills and sustained running through the winter time trial.

Feedback was received at the committee meetings that members would like to see more hills and the Mo Farah goes down really well. Notification was put out through the newsletter and Wednesday summer training briefings for members to highlight anything that they would like to see in the schedule. No feedback has been received from this request so far, so I have gone with the committee

meeting feedback. The schedule now includes more hills, another Mo Farah session and an increase in sessions more like the Mo Farah training.

Having created schedules for the last 8 years with no adverse comments or feedback I feel as coaches we are doing it right. It is difficult to please everyone and keep a schedule as varied as possible to cater for all our members.

It looks like the ongoing council works from last year have now settled, so hopefully Berewood will be able to be used again. I believe running around the pool last year was not too bad as long as we reinforce our H&S notice about cars etc.. Also, feedback about using the pool circuit again was positive. I have kept the 200's on this circuit as it is the safer option, Berewood was becoming too crowded with the short fast session. Also, if a coach wishes to use the pool circuit for a different session, I have no issue with this as long as they announce the appropriate H&S warnings.

We shall continue to split the hill session between Hurstville (L1 & L2) and Drayton Road (L2 & L3)

The schedule will shortly be sent out via email and uploaded to facebook and the website.

### 4.0 Denmead 10k Committee.

Entries are currently sitting at 224 with over 6 weeks to go so it's looking likely we will sell out. Only 4 striders have entered the race so far.

There has been some speculation about whether badgergate is over or not but it's been decided that we continue to run regardless as the road is only closed to vehicles. Gav is still waiting to hear from the council re road closure. He will chase.

Everything else is booked, double checked and ready to go! Pacers have been selected, Paul has put a marshal call out and has received a good number of offers of help. Profit is currently looking like £1700.
